NARRATIVE

The victim, Darrell Bazemore, stated that he was assaulted by a fellow Fraternity brother while sitted in a SUV in the Freshman Dorms Loading Dock. He advised that the suspect, Christian Hill, was upset because he would not move from the passenger seat. The victim advised that the suspect demanded that he move to the back seat but when he refused after 10 minutes of back and forth request and refusals the suspect stated "Folks think I'm playing with them" and then walked around to the passenger side door. The victim proceeded to close the door and the suspect opened the door and physically grabbed his leg and jerked it repeatedly. The victim tried to get his leg released by the suspect but was unsuccessful. The victim advised that the suspect then grabbed his arm and leg and threw him from the seat. He advised that he fell from the SUV and landed on his arm causing his arm to pop out of place, which he was able to pop back in place. The incident was first reported to the Dean of Students Office on 03/18/13 and then to the Police Department 03/20/13. A copy of the video was forwarded to myself from the University Housing. He was given a Victim's Rights pamphlet and advised that he could receive a copy of the Police report within 3 business days.
